Minutes

The board meeting started at 16:30

1. Orientation from 'old board members'

- Emilie: Our main task is to made events for our fellow students, but to be honest, it has been a hard job. We have had many ideas, but we has often been in lack of volunteers who could help organise the events. On the other hand, it is fun to be part of the board. It is a great challenge and we are no longer afraid of talking in front of many people. It is stressful, when you are responsible of seven Introbars in 6 days.
- When elected for the board, we all has the responsibility to do our best for the students and the school. It is not "what is in it for me" but "what can I do for the school". You have the opportunity to be part of a team and improve your competences on a specific area.



 Twice a year – in the end of the semester – we have a party/gathering for the Volunteers, but besides that activities planned by Students has to benefit all students.

The board cannot decide to arrange only for board members or few, selected students.

- Twice a year we had a tradition in cooperation with HK to have an conference for all volunteers
- We had a tradition of making Fælles in Fælled in September. It is important to plan activities forcing students to talk to each other 'cross-classes' and not only those from their own class.

• Study start:

It is our experience, it is worth it – in cooperation with the school – to plan to visit as many classes as possible and introduce Cphbusiness Students to the new students.

We also plan a meeting 2 – 3 weeks after study start where interested students can come an learn more about how it is to be volunteer in the Students.

- All agreed at the next board meeting to constitute chairman and vice chairman.
