# 6. Financial orientation / treasurer Isabella

Current balance: +124.317,65 DKK

The student organisation just received the grant for approx. 40,000 DKK from the Ministry of Higher Education and Science. Student organisations in Denmark get a yearly grant from the Ministry of Higher Education and Science. The amount depends on the number of students.

- Suggestion from Charlotte: The student organisation should no longer receive the quarterly grant from Cphbusiness. This is due to the fact that the student organisation has not been able to host events for the grant, which was the purpose, and due to the fact that the student organisation now recevive a grant from the Ministry. In order to make sure the grant from Cphbusiness is used for student activities, the grant will be dedicated to student activities via Study and Career.
  - The suggestion was put to a vote: Approved

# Bank account access:
