Comments for the budget:

- Jana: 1.000 DKK annually for hosting the bank account seems expensive.
  - 1. Anna: It is expensive, but it looks like it is the same no matter which bank you choose. Anna will keep an eye on the price development for this.
- Jana expressed her concern about the lack of income sources.
  - 1. Charlotte explained that there are still 200.000 DKK allocated for the student organisation, which will be transferred when its needed.

# 7. Orientation from the chairmanship

Status on volunteers (how many in which teams)

- Charlotte: The corona task force has informed us that we are not allowed to meet physical on campus at the moment. Anna and Charlotte will continue to ask the corona task force regularly.
- Jamie: In HR we have reached out to each volunteer to get an update. It is very hard to get a response.

Student politics: Angel

- The national student organisation DESO:
  - DESO (Danske Erhvervsakademiers Studenterorganisation) is the newly founded national student organisation representing all business academies in Denmark. Having a student organization representing all business academies in Denmark means that it now will be much easier for the business academy students to be represented in a long line of student political arenas and councils.
  - DESO was founded 8 April 2021 at a constituting annual general meeting where Angel, Jana and Charlotte participated on behalf of Cphbusiness.
  - Each business academy is automatically allocated two seats in the board of DESO. Jana and Angel are sitting in this board due to their chairmanship.
  - Suggestion to add an update from DESO on the agenda for each board meeting. This was supported.
- Due to the chairmanship, Angel was a judge in the Cphbusiness Internship of the Year.
- Status on the event in April: 14-15 participants, it went well.
- Activities for the rest of the semester:
  - o 6<sup>th</sup> of May social event for volunteers. Potential volunteers can be invited.
    - Monika: Business Danmark had some good teambuilding exercises that could be interesting.
    - Anna and Charlotte: Remember to talk to HK as well.
  - o Celebration event in June will only be held if it can be held physical.

- The student organisation has a LinkedIn page, but who manage this.
- Team Relation where Anna and Charlotte work, has founded a new newsletter called "Studieliv" (student life) telling students at Cphbusiness about the social activities at Cphbusiness. The student organization is very welcome to contribute with content to these newsletters.
